ESG quality score

The ESG quality score provides an indication of constituent companies' ability to manage risk and opportunities arising from ESG exposures in the Active Super International Portfolio.

In the First-Half of 2022, the ESG Quality Score was 6.55 compared with 6.3 in 2021 with a 5-year moving average of 5.8.

Key ESG Quality Score detractors within the Active Super International Portfolio include the Consumer Financial Protection Pillar.



ESG Pillars Score provides a breakdown of constituent companies' exposure to each individual ESG Pillar in the Active Super International Portfolio.








ESG rating distribution


ESG quality score

ESG Quality Score Trend




ESG pillars score

Environment Trend













Top-performing ESG categories
